4. Stanchions & Chain: We ask that all car owners furnish their own to improve the appearance of their display or rent the same from the show management at a nominal fee.
5. Neither the Producer, the Sponsor, nor any officer, director, or shareholder thereof, or the owner of the building at which the show is produced, shall be responsible or liable for any loss of or damage to all or any part of the Exhibitor's display and/or vehicle, and the Exhibitor shall and does hereby waive any and all rights he may have against them or any of them for any such loss or damage.
6. Show producer reserves the right to use any photo of participants in future advertising of show.
